Water Heating Equipment Rebates and Financing

Rebates up to \$500 and Financing up to \$3,500*

Upgrade to qualifying equipment and you may be eligible for rebates and incentives from New Jersey Natural Gas (NJNG), including 0% APR financing through NJNG's On-Bill Repayment Program (OBRP).*

Replace what you need now and return later to access even more rebates and incentives for additional equipment upgrades. Enhanced rebates and financing options are available for income-eligible customers.

Indirect , when paired with a AFUE 90% gas boiler	Finance up to \$2,500	And/Or	\$250 NJNG Rebate
Gas Storage Tank Water Heater >55 gallons, UEF ≥.78 med. draw, UEF ≥.80 high draw or ≥TE .90**	Finance up to \$2,500	And/Or	\$450 NJNG Rebate
Tankless Water Heater UEF≥0.87	Finance up to \$3,500	And/Or	\$500 NJNG Rebate

Note there is a financing cap on water heating equipment (see above). All loans are net NJNG rebates. Install a qualified water heater and furnace or boiler at the same time and you could be eligible for additional incentives. Terms and conditions apply. NJNG bonus incentive is available for income-eligible customers.

For example, on a \$15,000 repayment with an APR of 0% and a term of 10 years, the customer would make 120 payments of \$125. NJNG reserves the right, with approval of the State of New Jersey Board of Public Utilities, to terminate, modify, suspend or extend this rebate program. NJNG rebates and incentives do not apply to new construction. Offer applies to equipment purchased and installed by June 30, 2024. Rebate applications must be postmarked within 120 days of equipment purchase date. Customer must submit a paid receipt and proof of permit with NJNG application.
